Tribally-Owned Benefits

- ✓ No dollar ceiling on set-asides or sole source contracts 13CFR§124.311(b)
- ✓ No justification or approval (J&A) for awards under \$100M for DoD; \$25M for non-DoD agencies - FAR 6.303-1
- ✓ Tribal awards cannot be protested - 13CFR§124.517(a)
- ✓ No requirement for a procurement to undergo competition before it can be awarded on a sole source basis to a tribal firm (13 CFR § 124.506(b))
- ✓ Agencies may make sole-source awards to tribally-owned firms at any time, even when the contracting officer reasonably expects that at least two responsible 8(a) firms will submit offers and the award can be made at a fair market price - 13CFR§124.506(a)
